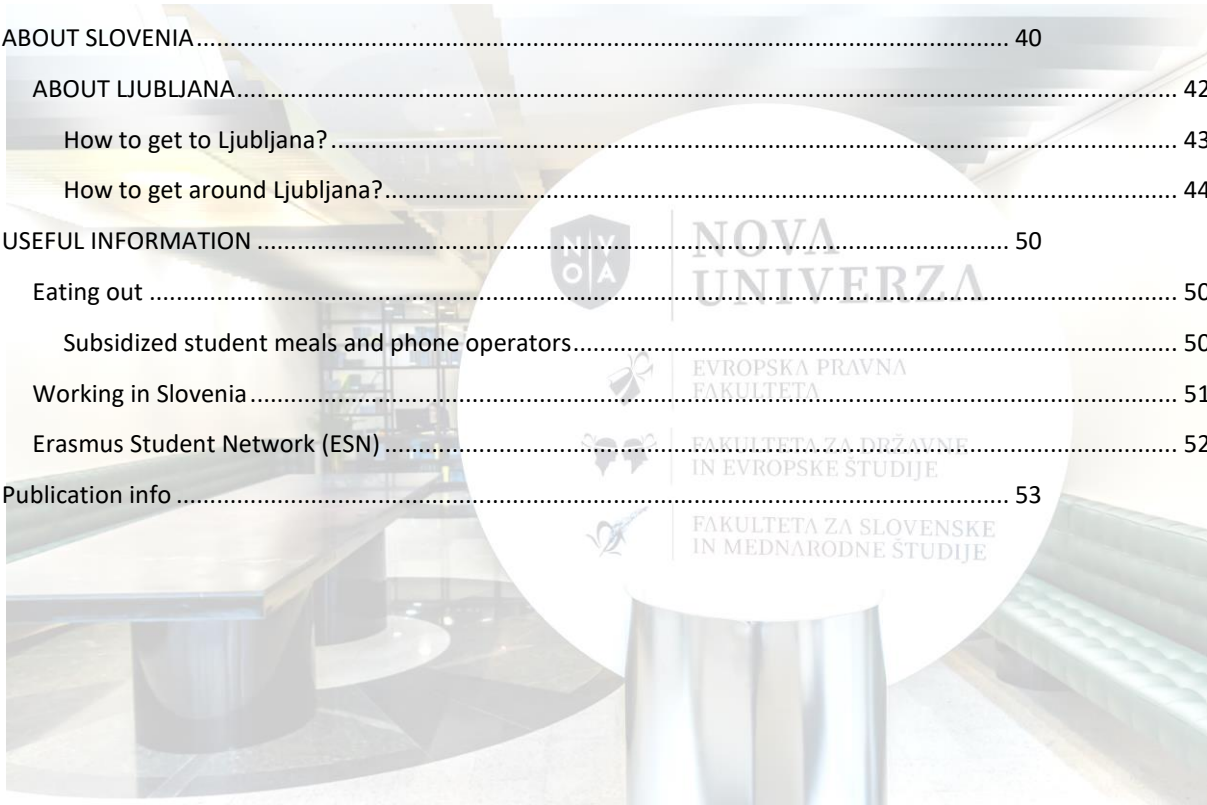

EUROPEAN FACULTY OF LAW

The European Faculty of Law is a private higher education institution. It was the first law faculty in Slovenia that developed its study programmes in correspondence with the European Bologna model of studies.

The faculty was founded in 2005 by the Institute for Human Rights, Advice and Education, the Institute of International Law and the Institute of Civil Law. Later, in 2017, it became a full member of the New University.

Faculty's head office is in Nova Gorica. It also has branch units in Ljubljana and Maribor. Lectures are held on all locations. The Erasmus+ program and all Erasmus+ activities are carried out in Ljubljana.

Nominations should be sent to our institutional coordinator at e-mail: international@nova-uni.si via the nomination form available [HERE](#).

Student nominations must reach the receiving institution by:

- **Autumn term: 15th May**
- **Spring term: 15th November**

APPLICATION PROCESS

After your home university has successfully nominated you as an exchange student, you should fill in the [New University Erasmus application form](#). The scanned copy of the signed and stamped application form together with all required annexes must be sent to the Centre for Career Development and International Mobility of the New University at international@nova-uni.si until 15th June (winter semester) and 15th December (summer semester).

Required annexes:

- Home faculty statement of participation in the Erasmus+ mobility
- Certificate of enrolment
- Motivation
- Curriculum Vitae
- Learning agreement
- Copy of ID or passport
- Proof of language proficiency
- Transcript of records with average study grade

Application forms must reach the receiving institution by:

- **Autumn term: 15th June**
- **Spring term: 15th December**

After New University has received your application and it has been carefully evaluated, the Centre for Career Development and International Mobility of the New University will send you an **Acceptance letter** and **general information** on living and studying in Slovenia. The institution will send its decision within 4 weeks, and no later than 5 weeks after the application deadline.

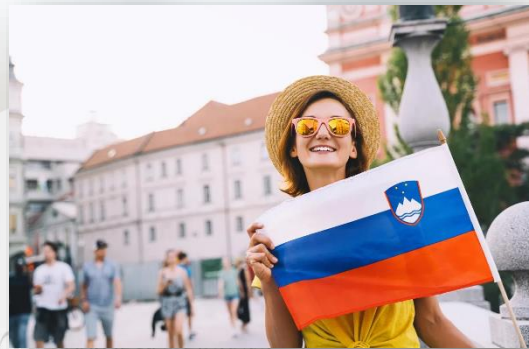

Displaying the flag of the Republic of Slovenia on holiday

The Act Regulating the Coat-of-Arms, Flag and Anthem of the Republic of Slovenia and the Flag of the Slovenian Nation lays down that the flag of the Republic of Slovenia is to be displayed during national holidays in the Republic of Slovenia:

- on 8 February, Prešeren Day, the Slovenian Cultural Holiday,
- 27 April, Day of Uprising Against the Occupation,
- 1 and 2 May, Labour Day,
- 25 June, Statehood Day, and
- 26 December, Independence Day.

The flag is to be displayed on buildings that are the official premises of state authorities and local community authorities, and may also be displayed on other public buildings, residential buildings and other appropriate locations. The flag is to be displayed for the duration of the holiday. In addition to the flag of the Republic of Slovenia, the flag of the Slovenian nation may also be displayed. In the geographic areas where the Italian or Hungarian national communities reside, the national community flag is also displayed.

After the adoption of the Act Regulating the Coat-of-Arms, Flag and Anthem of the Republic of Slovenia and the Flag of the Slovenian Nation in 1994, the following national holidays were declared:

- 8 June: Primož Trubar Day,
- 17 August: Unification of Prekmurje Slovenes with the Mother Nation,
- 15 September: Return of Primorska to the Motherland,
- 25 October: Sovereignty Day,
- 23 November: Rudolf Maister Day.

The rules of displaying the flag of the Republic of Slovenia on these holidays laid down by the Act Regulating the Coat-of-Arms, Flag and Anthem of the Republic of Slovenia and the Flag of the Slovenian Nation shall apply *mutatis mutandis*, which means that the flag may be displayed.

ERASMUS+ COURSE CATALOGUE

The New University Course Catalogue is very important for students at the University. Here, you can look up details on each programme and each specialisation (where applicable), displaying an overview of courses by year and semester.

Students are encouraged to familiarise themselves with study information in the Course Catalogue, as well as the main information below regarding Study programmes carried out by New University faculties members. All courses for Erasmus students are provided in **English language**. **The New University Course catalogue can be found [HERE](#).**

These courses consist of **lectures, seminars, tutorials, individual studies, examinations or other assessment activities** which lead to a successful completion of the course. Since being a small and private higher education institution, New University offers to Erasmus+ and other incoming exchange students an individually oriented and **unique learning experience**.



Our pedagogical and methodological approach is based on direct **knowledge transfer** which is ensured by **close liaison between students and lecturers**, a remarkable combination of youth and professional academic experience, and contemporary and practically oriented research and teaching content.

Most lectures are performed **as individual consultations with lecturers in small groups** (up to 5 students) where various topics of the course are precisely discussed during the meetings. Consultations are primarily conducted in person, providing participants with valuable face-to-face interactions and

fostering a sense of community and collaboration. Such in-person meetings offer numerous **benefits, including the opportunity for spontaneous discussions, nonverbal communication, and interpersonal connections**. Participants can actively engage with course content, collaborate on group activities, and build meaningful relationships with peers and lecturers, fostering a sense of belonging to the New University community.



When there are larger groups of incoming students per semester, the courses are performed in **Erasmus+ classes or exceptionally together with home students**. The language of instruction for Erasmus+ students is primarily English, but in case of sufficient Slovenian language background, **international students can join Slovenian students in various curricular or extracurricular activities**. Erasmus students can choose subjects from different faculties members. The majority of chosen subjects in each Learning agreement have to be from the faculty that covers study areas, specified in the Erasmus+ Interinstitutional Agreement.

New University performs several study programs via faculties members. Here is a list of study programs available for Slovenian students.



GRADING SYSTEM, LANGUAGE REQUIREMENTS AND SUPPORT

HIGHER EDUCATION SYSTEM IN SLOVENIA

Slovenia is part of the European Higher Education Area (a.k.a. Bologna system). Thus, studies are divided into 1st, 2nd, and 3rd cycle.

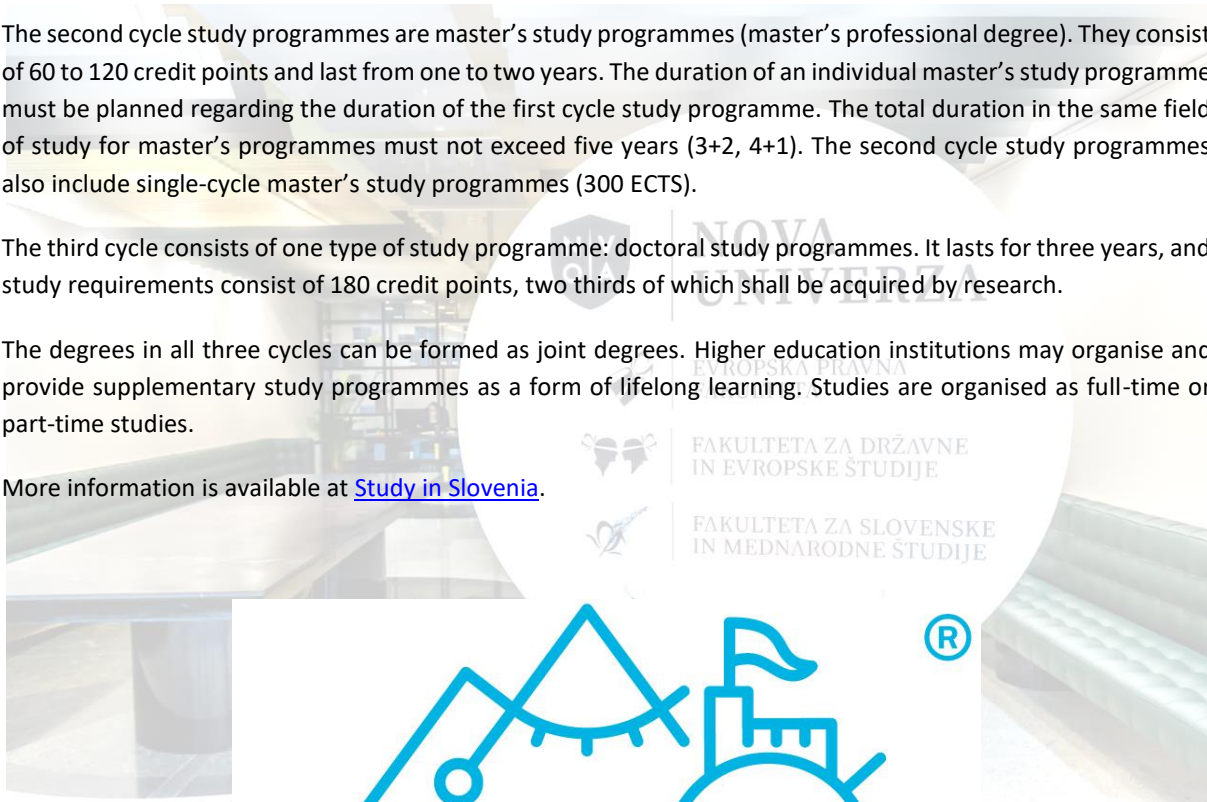
The first cycle study programmes are academic and professional study programmes. Their duration is determined by years (three to four years) and ECTS credit points (180 to 240 ECTS). 60 credit points may be obtained per study year; 1 credit point consists of 25 to 30 hours of a student's work.

The second cycle study programmes are master's study programmes (master's professional degree). They consist of 60 to 120 credit points and last from one to two years. The duration of an individual master's study programme must be planned regarding the duration of the first cycle study programme. The total duration in the same field of study for master's programmes must not exceed five years (3+2, 4+1). The second cycle study programmes also include single-cycle master's study programmes (300 ECTS).

The third cycle consists of one type of study programme: doctoral study programmes. It lasts for three years, and study requirements consist of 180 credit points, two thirds of which shall be acquired by research.

The degrees in all three cycles can be formed as joint degrees. Higher education institutions may organise and provide supplementary study programmes as a form of lifelong learning. Studies are organised as full-time or part-time studies.

GRADING SYSTEM

Students' learning achievements are graded according to the Slovene grading system, which is transferred in the European Credit Transfer and Accumulation System (ECTS) as follows:

SLOVENE GRADING SCHEME	ECTS GRADING SCHEME	DESCRIPTION
10 (Excellent)	10 (Excellent)	Outstanding performance with only minor errors.
9 (Very Good)	B (Very Good)	Above the average standard but with some errors.
8 (Very Good)	C (Good)	Generally good work with some notable errors.
7 (Good)	D (Satisfactory)	Fair but with significant shortcomings.
6 (Poor)	E (Sufficient)	Performance meets the minimum criteria.
5 – 1 (Unsatisfactory)	F, FX (Fail)	Considerable further work is required.

A student passes the exam if he/she is graded from 6 to 10. Study requirements may also be evaluated with grades: passed with distinction, passed, or failed.

LANGUAGE REQUIREMENTS

New University offers instruction in the following languages: **Slovenian and English.**

International students are required to have good language skills in at least one of the two languages to be able to study in Slovenia.

Students must present a language certificate of their Slovene or English language skills. Very good language skills refer to level B2 of [Common European Framework of Reference](#) scale. Minimum language requirements:

- **Slovene B2,**
- **English B2.**

Students with insufficient language background have

As a proof of the language skills (Slovene or English), you can submit one of the following certificates to your Erasmus+ coordinator:

- a Transcript of Records of the home university where language skills are visible,
- Language Certificate with CEFR scale,
- Results from the OLS (Online Language Support),
- a TOEFL score of 79 (IBT) or IELTS score of 6 for English,
- any other official certificate that proves the language skills.

When students have insufficient language skills, following classes can indeed be challenging. Such students will encounter many difficulties such as reading and writing difficulties, comprehension challenges, participation barriers, note-taking issues, test and assignment concerns, difficulties in cultural and contextual understanding as also emotional and psychological impacts.



INTENSIVE COURSE OF SLOVENE FOR ERASMUS+ STUDENTS

Students must pay attention to foreign language skills in the host country. The faculties give foreign students all the necessary information about language courses in Slovenia.

The [Intensive Course of Slovene for Erasmus+ Students](#) is only intended for students registered in a higher education institution holding an Erasmus Charter for Higher Education (ECHE), who have been selected for an Erasmus+ study/placement period. The course is co-funded by the European Union. The course is intended for beginners in Slovene.

[Slovene Learning Online](http://www.slonline.si) is a **freely accessible online course of Slovene** for foreigners, developed at the Centre for Slovene as a Second and Foreign Language in cooperation with the company DigiEd. The course is designed for those who wish to learn Slovene on their own in a simple, playful, and effective way.

They have published **SLO 3** - the third part of the free online course for learning Slovenian **SLOVENE LEARNING ONLINE**, which is available at www.slonline.si. In the first two parts (**SLO 1, SLO 2**), students can learn vocabulary and communication patterns, while the third part (SLO 3) includes selected grammar content.

Learning is facilitated through translations, which are accompanied by visual and audio content and a variety of interactive exercises. Students can choose from translations into seven languages to assist you learn: English, French, Croatian, Italian, German, Russian, and Spanish. We also invite you to watch the animation, which is available on [Facebook profile](#) and [YouTube](#) channel.

We encourage you to take a look at these resources and, with their assistance, contribute even more to Slovenian language learning!

INCLUSION AND ACCESSIBILITY

The New University enables students with special needs suitable adjustments of the study process that assure their equal participation and integration into all procedures at the faculty. Thus, the New University is responsible to provide equal rights and access to information available to the public.

Students with special needs are in accordance with the **Rules of studies of the faculty members of New University** entitled to **special benefits**. The latter defines terms for granting a status of a student with special needs and common rights and adjustments of the study process. In order to enforce the rights arising from the mentioned Rules, the students must submit an application to the Commission for Student Affairs at the European Faculty of Law.

In specific cases, the New University enables individual procedures that are based on coordination of individual student's needs on one side and characteristics of a single study programme on the other. The support in the field of enrolment, introduction into the study process, adjustment of study materials and study support to students with special needs is provided by the Faculty's Student Office.

The Career Centre of the New University also provides students with special needs with different forms of **individual assistance**. Herewith it provides individual career counselling, support in selection of studies, support at the introduction into the study process, assistance in career plan preparation, various free workshops to obtain additional knowledge, visits to working environments, presentations of employers, assistance in transition into employment (preparation of written presentation, preparation of innovative presentation to the employer) and other activities.

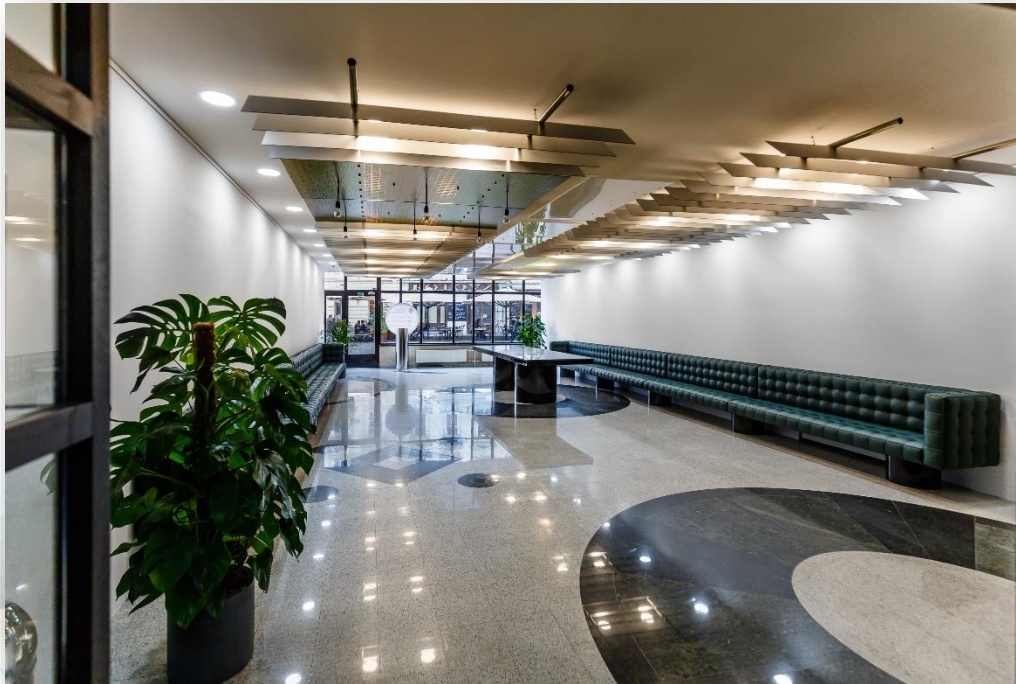

Statute of the New University	<p>Legal structure and purpose of New University as an independent and private higher education institute which carries out university educational, scientific, research, academic and consultancy activities in the field of legal and legal-related sciences.</p>
Technical instructions for the preparation of thesis	<p>Instructions for diploma and master thesis and doctoral dissertation are commonly used as instructions for ERASMUS SEMINAR PAPER WRITING. It is also useful for Erasmus+ incoming students to prepare seminar papers as written exams.</p>



HOUSING AND ACCOMODATION

The Erasmus+ programme of New University is implemented by all member faculties of New University which are geographically spread throughout the country (Nova Gorica, Kranj, Maribor and Ljubljana) making the New University a distinctively all-Slovene higher education institution.

All activities for the New University Erasmus+ program are centralized and conducted exclusively at New University premises in Ljubljana, in the city centre, providing a cohesive and immersive experience for participants. Despite that, students can individually visit (daily trip) all New University study centers during their mobility period.

Ljubljana is the central hub for all Erasmus+ activities, including lectures, seminars, workshops, cultural events, and administrative tasks. By consolidating activities in Ljubljana, participants have access to a wide range of resources and facilities, including state-of-the-art classrooms, libraries, research centers, and student support services. This centralized infrastructure enhances the learning environment and supports academic and personal development.

ACCOMMODATION IN LJUBLJANA

In Ljubljana, during their stay students can choose between:

- student dormitories;
- private accommodation.

STUDENT DORMITORIES IN LJUBLJANA

Beds for Erasmus students in the student dormitories are available. The rooms are mostly double, kitchen, bathroom and toilets are shared with 3 or more students. In the student dorms there are blankets, pillows and bed-sheets, but you should bring your own towels. All rooms have an internet connection; you just need your UTP cable.

All campuses are located near the centre and offer plenty of opportunities for sport and recreation. On campuses students can use for free: fitness facilities, computer centre with computers and free internet access, a laundry room with washing and drying machines, music room, room for parties. All dorms also have night and day security.

You must pay a security deposit before your arrival, which will be refunded after your departure if there is no damage done to your room. You also have to pay the rent for the whole semester in one single instalment; you can pay either, together with the deposit, through the bank, or when you arrive in dorm.



The price varies from 150 - 190€ per month per person, depending on the size and location of the room. Foreign students pay the economic price. Rooms are given to students on "first come, first get" basis according to the date and hour of the online application.

NOTE: In the past academic years, due to the extensive construction and renovation of the student dormitories in Ljubljana, accommodation for Erasmus+ students was not guaranteed. Foreign students were invited to find private accommodation in Ljubljana.

The availability of the accommodation for Erasmus+ students in student dormitories for the upcoming academic years is not yet predictable. Students are invited to express their interest in student dormitories during the Application process. All students will be informed about the availability of accommodation in dormitories prior their mobility via email.

SUBSIDISED STUDENT MEALS

Slovenia is the only country in Europe with the coupons systems called “ŠTUDENSKI BONI”. This means that you can eat a nice student meal in certain restaurants in Ljubljana or everywhere in Slovenia for 4,5 EUR on average. The Slovenian Government subsidises the rest of the meal’s price.

If you order a drink or a meal that exceeds the price of the subsidised meal, you need to pay the price difference. You can eat two meals per day with 4 hours interval between meals. Students are entitled to usually around 20 meals a month. The prices of meals differ from restaurant to restaurant, their location and meals they offer.

For some coupons, you can get a sandwich or a hamburger, and for others a whole meal with soup, main dish, salad and dessert.

All Erasmus+ Exchange students enrolled at New University are entitled to subsidised meals in participating restaurants around Ljubljana and Slovenia. Prices range per meal goes from 3 EUR up to 10 EUR.

In order to be able to use these subsidies, you need to have a student card or your **enrolment certificate, your ID/passport and your mobile phone (with Slovenian sim card).**

In order to register, students are required to submit an online application form through Študentska prehrana (studentska-prehrana.si) and then visit the nearest Subsidised Student Meal point with their registration number, ID card/passport and Student ID card or Acceptance letter.

HEALTH CARE AND INSURANCE

EU STUDENTS

Students within the EU area should bring with them basic EU health insurance from their own country – the [European Health Insurance Card \(EHIC\)](#). For additional types of insurance (accident insurance, etc.) they may enter one of international health insurance schemes (e.g. [CORIS](#), [Vzajemna](#)) in Slovenia. International students are advised to make a copy of their health insurance and leave it by their Erasmus+ coordinator, friends, mentor, etc., in case of an accident.



NON-EU STUDENTS

Students should be properly insured already at the time of obtaining a residence permit (while still at home). They must get health insurance that covers the EU area or only Slovenia. Students from countries that have signed a special social and health insurance agreement with Slovenia may take the opportunity of that. International students are advised to make a copy of their health insurance and leave it by their Erasmus+ coordinator, friends, mentor, etc., in case of an accident.

VISITING A DOCTOR

It's important for students to familiarize themselves with the healthcare system in Slovenia, including how to access emergency services if needed. Additionally, students should ensure they have the necessary health insurance coverage for their time abroad.

When needed all Erasmus+ and international exchange students of the New University can find medical assistance in the [Health Centre for students](#) where they can receive proper medical care or treatment.



Students from the EU countries need a Health Insurance Card and two photocopies of it. Students from countries outside the EU must bring a document confirming that they have insurance in their home country, along with their passports. Students from non-EU countries can either arrange their insurance in Slovenia, which costs approximately 110 EUR (per month) or pay for necessary medical treatment. However, we strongly advise obtaining insurance with insurance company in your home country, which offers arrangements for time spent abroad. Later you may ask for reimbursement of medical expenses in your home country – please check the details at your insurance company.

HOW TO GET TO LJUBLJANA?

BY AIR: [Ljubljana Jože Pučnik Airport](#) is the main airport of the country. It is located 30 km from the centre of Ljubljana and has good connections with other European cities. Different options of public transport take you from the airport to Ljubljana in around half an hour.

Because of the proximity of some Airports (Venice, Trieste – Italy, Zagreb – Croatia, Graz and Klagenfurt – Austria) to Slovenia students arrive also by **low cost airlines**, flying to these airports.



BY TRAIN: Ljubljana has good railway connections with all large European cities. The railway station is located in the centre of Ljubljana. Organisations in your own country may offer discounts to students and other under age 26. Train travel within Slovenia is convenient and inexpensive. For more information, please look [HERE](#).

HOW TO GET AROUND LJUBLJANA?

BUS – CITY PUBLIC TRANSPORT

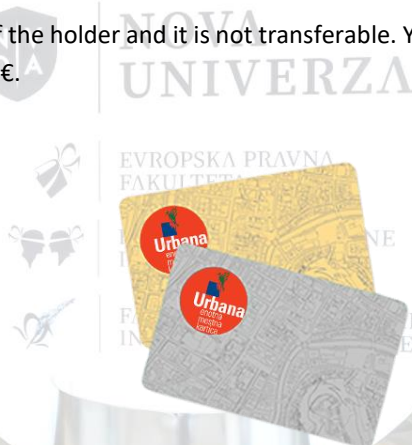
City buses have electronic payment system based on no-contact smart card called **Urbana**. **Urbana cards are available in news-stand (kiosk), post offices, turist informaticon centers (TIC)**. Urbana cards are electronic ticket carriers. URBANA value card (yellow) is without a name of the holder and is transferable. You can buy and top it



up with credit up to 50 EUR (at **Urbanomat** top-up stations; the lowest amount of credit is 1 EUR) or with transferable monthly and yearly tickets.



URBANA time card (green) is issued with the name of the holder and it is not transferable. You can top it up with a selected monthly ticket and/or with credit up to 50€.



Both types of cards are valid on all Ljubljana city bus routes. The credit does not lapse. The payment must be made at the beginning of the ride by touching with your card at one of the green readers (validators) on the bus. One fare will cost you **1,30€ including max 90 min ride** within all the City Public Transport bus routes.

However, you should validate your card (touch the reader with the card Urbana) every time you enter the bus. In order to pay for two or more passengers, please tell the bus driver – before validation at the driver's reader (validator) – that you wish to buy more than one ticket and how many would you like to buy. The passengers you paid for should during the ride stay near you.

Mobile application Urbana

Urbana City Card Users can install [Urbana Mobile Application](#) on their Android smartphones, which serves as a virtual value card. Urbana mobile application enables quick and easy payment for:

- bus travel (LPP),
- parking facilities (JP LPT),

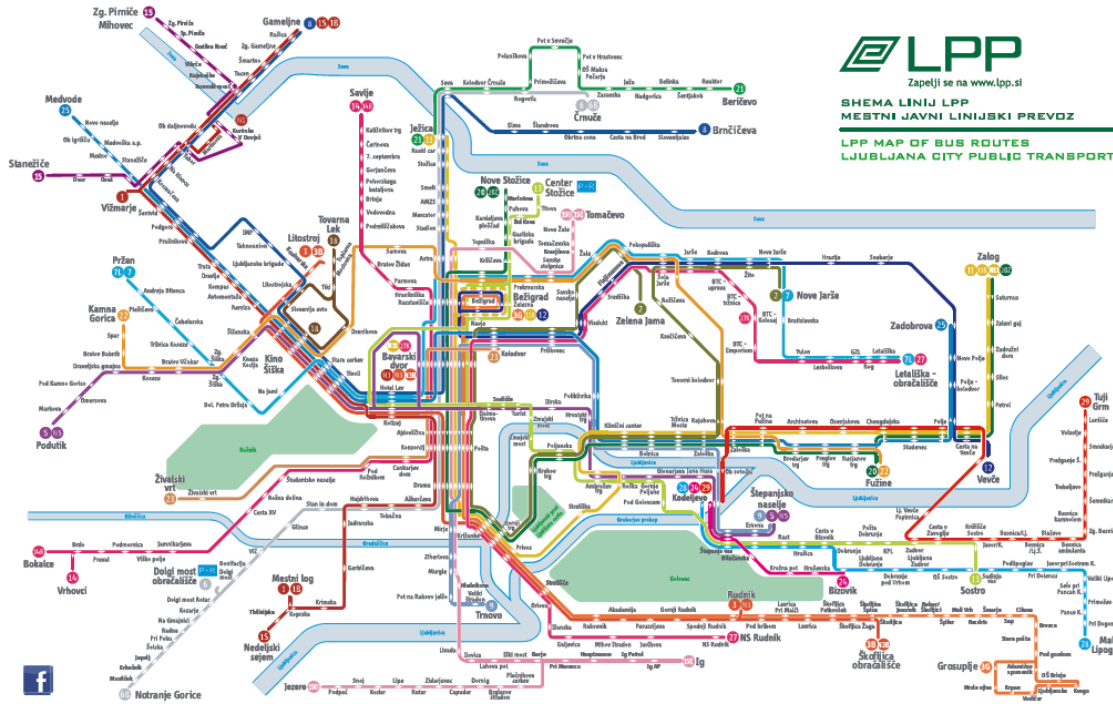


- riding with the funicular (Ljubljana Castle),

TICKETS: All tickets are carried on Urbana cards. Value ticket: single fare paid from pre-paid credit on Urbana card that enables free transfers within 90 minutes. **Personalised monthly tickets:** valid for an unlimited number of rides on all routes from the 1st day of the month until the 5th day of the following month. No photo necessary. A range of monthly tickets are available, some of them at subsidised prices. For more information please enquire at LPP Information Centre. EATING OUT



The influence of the East and West, North and South have mingled in Slovenia, a phenomenon noticeable in Slovenia's traditional dishes. The city of Ljubljana offers a great variety of cuisine and by available prices. Most restaurants serve food until 11 p.m., but some do so until the early morning. There are also numerous specialised national restaurants: Chinese, Italian, Mexican, Thai and Spanish. The tip is not included in the price of the meal and is not obligatory. In general, eating out in

restaurants outside the system of subsidized student meals is not cheap.

SUBSIDIZED STUDENT MEALS AND PHONE OPERATORS

Please remember, that by being an exchange student, you can use a **system of subsidized student meals** that have been described in previous chapters. The system is used in the majority of restaurants in Ljubljana and also in other cities in Slovenia. To be able to register you need your mobile phone for identification Slovenian SIM card and Enrollment confirmation issued by New University.

WORKING IN SLOVENIA

Students wishing to seek for a long-term employment in Slovenia need to obtain a work permit. Exchange students, however, do not need a work permit.

In Slovenia students can work through an 'Student Work'. This allows temporary college and university students. They can of contract called referral forms/referrals, from employment agencies specialised Agencies, called **Student Services (SS)**, offer lists of available student jobs and take care of payments. There are many different agencies around Slovenia.

You can also work via the Student Service agency if you are a student from a foreign country and are living in Slovenia through international exchange programmes (studying or internship). For enrolment with the SS agency system you need to provide:

1. Identification Document (ID)
2. [Slovenian bank account](#)
3. Slovenian tax number
4. Certificate of enrolment
5. [Proof of residency](#) (optional)

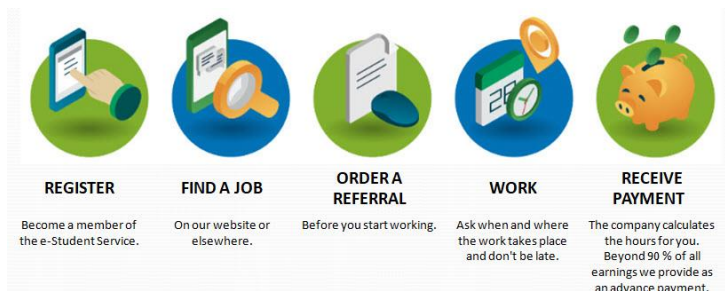

When you have all the above, go to the chosen agency and enrol in their system. The agencies have lists of available jobs, but you can also find a job on your own and inform the agency about the company. The agency will provide you with a referral form, which you give to the employer. These are the conditions for working in Slovenia as a student.

You can work via Student Service if you have student status in Slovenia (if you are a foreign citizen and you study in Slovenia) or if you are doing your practice or studies as a part of an international exchange programmes in Slovenia.

Work is based on the work referral forms, which you get in our office before you start work. After the work is finished your employer returns filled-in, sealed and signed referral. You get transferred all the income without delay in the moment the company pays the invoice. For the companies with good credit ranking, we even pay you in advance, before the company pays the invoice.
